## 2024 BREEDING SHED REQUIREMENTS

### GENERAL REQUIREMENTS:

**FOR 2024 – All mares visiting our breeding shed must be vaccinated from 7 to 90 days before breeding for equine herpes virus type 1 (Vaccines: Rhinomune, Pneumabort-K, etc.). A statement to this effect should accompany the mare to the breeding shed (may be included on culture certificate or hand written on our breeding shed form).**

- 1) **ALL DOMESTIC FOALING MARES:** There will be no breeding requirements on these mares for the first trip.
- 2) **ALL DOMESTIC BARREN MARES:** In each heat cycle, these mares must be accompanied by a negative regular (aerobic) culture taken within 30 days of cover by an attending veterinarian in Kentucky prior to breeding.
- 3) **DOMESTIC MAIDEN MARES:** In each heat cycle, all maiden mares are required to be accompanied by a negative regular (aerobic) culture taken within 30 days of cover. All maiden mares must be jumped before coming to the shed.
- 4) **IMPORTED FOALING AND BARREN MARES:** All imported mares not previously bred in the United States will be required to have two sets of negative CEM cultures (one to be from endometrium) prior to being bred as specified in the Kentucky Department of Agriculture Guidelines. Barren mares from CEM countries must also have a negative culture from the cervix. These mares must also be accompanied initially by a quarantine release. The first three mares bred by the same stallion after the imported mares must have a CF test 15 to 25 days post-breeding. The owners of these mares are responsible for having the CF test done and for sending the results to the State Veterinarian's Office. Note: Proof that the CF blood has been drawn must accompany an imported mare returning for a second cover.
- 5) **IMPORTED MAIDEN MARES:** All fillies of foreign origin, except from Canada, which have not been qualified for cover during the previous breeding season, are required to have two sets of negative CEM cultures on initial cover, as well as a pre-breeding CF test result. The requirement for a post-breeding CF test as described in #4 above applies to imported maidens.
- 6) Any mare returning for additional covers (not including doubles) must be accompanied by a negative regular culture from that heat period.

\*\*\*\*\*

ALL MARES MUST HAVE PROPER IDENTIFICATION WHEN COMING TO THE BREEDING SHED (I.E.; HALTER OR NECK STRAP WITH HER NAME ON IT). ALL MARES MUST ALSO BE ACCOMPANIED BY AN AIRDRIE STUD BREEDING SHED FORM ON **EVERY COVER**.
